- 1 Define systems of care
- 2 Apply the BLS assessment, primary assessment, and secondary assessment sequences for systematic evaluation of adult patients
- 3 Discuss how using rapid response teams (RRTs) or medical emergency teams (METs) may improve patient outcomes
- 4 Discuss early recognition and management of ACS, including appropriate disposition

- 6 Recognize bradycardia and tachycardia that may result in cardiac arrest or complicate resusciation outcome
